# 5. VEHICLES ELIGIBLE TO PARTICIPATE

All vehicles must be in conformity with the Technical Regulations of the FIA E-Rally Regularity Cup.

## 6. GENERAL CONDITIONS

- 6.1 The event will be organized in conformity with:
  - the FIA International Sporting Code and its appendices;
  - the Sporting Regulations of the FIA E-Rally Regularity Cup;
  - the applicable prescriptions stated in the National Sporting Regulations; and
  - the present Supplementary Regulations.

The Organizing Committee will ensure that the event complies with all the rules and regulations stated above, and that the event has received all the required administrative authorizations.

#### 6.2 Insurance

Icelandic law and regulations governing motorsport mandate all vehicles participating in a motorsport event on a closed circuit must have valid third party insurance.

As a regularity rally does not fall under the term "motorsport event on a closed circuit" normal car insurance applies.

All Icelandic insurance companies have confirmed that their normal car insurance is valid for a regularity event and this does not require further confirmation. For foreign registered cars the competitor must show written confirmation from the cars insurers that the insurance is also valid, without exception, for the competition part of the event.

The organiser holds a mandatory third party liability insurance of EUR 2.1 million, which will only be applicable should a car's insurance not cover the accident / liability.

# 7. ITINERARY AND LAYOUT

#### 7.1 General

The event is run over three sections, one per day. All sections will be used to measure the Energy Performance Index.

Cars will be required to enter Parc Fermé prior to the start of the event to be fully charged. Hydrogen cars will be escorted to the hydrogen filling station in Reykjavik to fill up before entering Parc Fermé at the start of each section.

During the charging stop at Flúðir on 21-August-2020 a tour to Geysir and Gullfoss (waterfall) is scheduled as well as a visit to the Secret Lagoon at Fluðir.

The event is run out of Reykjavik as described above in Article 1. Programme.

#### 7.4 Regrouping

There will be no regrouping during the competition.

## 8. RUNNING OF THE EVENT

#### 8.1 Nature of the event

The eRally Iceland 2020 is an E-Rally Regularity event combined, in accordance to the 2020 regulations. Each competitor will collect penalty points from the "Regularity Stages" and from the road connecting the sections (Time Control penalties) in accordance with the present Supplementary Regulations and Bulletins, which may be issued at a later stage.

#### 8.2 Start, Finish, Results

The start signal for the event will be given at ON Power, Bæjarháls 1, 110 Reykjavík on the 20-August-2020 @ 10:00, when the cars will be placed in Parc Fermé prior to the start. The first car will start at 20-August-2020 @ 16:00.

Between legs and after the finish the cars will remain in the Parc Fermé, which they will enter as soon as they finish the preceding leg.

The starting sequence will follow the participation number and the cars will be stared at one-minute intervals.

# 9. CHARGING (BEV/PHEV)

The organising committee will supply for recharging electric power which is compatible with charging in Mode 3, singlephase alternating current from 230 V 32 A, with type 1 standard connector or three-phase alternating current from 400 V 32 A with type 2 standard connector, depending on car type and needs.

# 10. ENERGY PERFORMANCE INDEX

The Energy performance Index will be measured during the whole event.

# 11. ENTRY PROCEDURE AND FEES

### 11.1 Entry fee

The amount of the entry fee is fixed for each crew comprising two people (driver and co-driver, or driver and navigator) and accepting the optional advertising proposed by the Organiser:

a.	Private entries:	EUR250

b. Legal entity entries: EU	JR400

An amount of EUR250 will be added to those not accepting the advertising proposed by the Organiser.

The Organiser will provide the participants with material and services as referred to in Art. 11 in the Sporting Regulations of the FIA E-Rally Regularity Cup.

#### 11.1 Refund of Entry Fee

Entry fees will be refunded in full:

- a. If the entry is not accepted.
- b. If the event is cancelled.

### 11.2 Crew documents

A crew comprises one driver and one co-driver, or one driver and one navigator. Both must be a holder of the following documents:

- a. Driving licence according to the entered vehicles (not applicable for the navigators only)
- b. Any grade of FIA licence, issued by their ASN, or
- c. a FIA licence, grade D (or equivalent), obtained for the event, and valid for its duration, which has been issued by their ASN or by the organiser's ASN (with the written permission of the competitor's ASN) and handed over to the participants at the latest during the administrative checks. It will be subject to the payment of a fee of EUR40 for drivers and EUR30 for co-drivers.
- d. Vehicle document permitting its free circulation on public roads.
- e. Should it be applicable, a vehicle document required in the Technical Regulations of the FIA E-Rally Regularity Cup.

A crews must show the vehicle's insurance certificate is in accordance with the traffic Code and valid for the event in accordance with Article 6.2. Foreign vehicles must have in their insurance certificate a statement stating it is also fully valid on the competitive sections as well as the road sections without exception. In addition the certificate must state the crews accident and injury insurance is also valid during the competition, both on competitive and road sections.

#### 11.3. Entry Form

Any person, or legal entity, wishing to participate to the event must submit to the Event secretariat, a properly filled-in and signed entry form on www.erally.is, together with all other requested documents, photos, etc. before Sunday, 16-August-2020 @ 23:59.

#### 11.4 Limit of participants

The number of participants is limited to a total of 30 electric vehicles, but no limitation is place on hydrogen powered vehicles. All entry forms received after the above number of vehicles has been accepted will be entered on a reserve list.



# 13. GENERAL CLASSIFICATION, FIA E-RALLY REGULARITY CUP, OTHER CLASSIFICATIONS – AWARDS

#### 13.1. FIA Classifications

The following classifications will be submitted to the FIA for the allocation of FIA E-Rally Regularity Cup:

- a. Regularity Tests
- b. Road Penalties
- c. Energy Performance Index
- d. Final Classification Drivers, Co-Drivers, and Manufactures.

The classification statements will contain the name and the date of the event; the first name, surname and nationality of Competitors, Drivers and Co-Drivers; the Vehicle Manufacturer as should be listed in the Manufacturers' Cup classification; and the Road penalty points, the Regularity Stages penalty points, the Energy Performance Index figures and the sum of penalty points.

#### 13.2. Icelandic 2020 Electric Regularity Rally Cup

The same information as is stated in Art. 13.1 will be submitted to the Icelandic Motorsport Association for Icelandic crews for the Icelandic 2020 Electric Regularity Rally Cup.

#### 13.3. Cup / Trophies

For final Classifications as stated in Art. 13.1 above, cup / trophies provided by the Organiser will be awarded to the three first placed competitors (Driver and Co-Driver) of the E-Rally Regularity Cup Classification.

The first three placed Icelandic competitors (Driver and Co-Driver) will be awarded the AKIS Electric Regularity Rally Cup for 2020.

#### 13.4. Souvenir awards

All competitors will be awarded a souvenir award.

# 14. PROTESTS / APPEALS

The amount of the protest fee is EUR300.

Protests against the preliminary official results of the Event must be lodged, in writing, in accordance with the prescriptions set in the ISC with the Clerk of the Course within 30 minutes of the moment of their posting on the official notice board. Upon the expiration of this time period, the preliminary results become final.

Every protest is eligible to be examined by the Stewards of the Event only if it is accompanied by the aforementioned protest fee defined in this article, which is not refundable should the protest fail to be upheld.

For the National Court of Appeal, the fee is EUR500.

For the FIA Court of Appeal, the fee is EUR3000

## 15. APPLICATION AND INTERPRETATION OF THE REGULATIONS

In case of a dispute over the interpretation of the regulations, the English text will prevail.
